

CYPRESS COUNTY

BYLAW 2022/03

Being a Bylaw of Cypress County to establish fees for information, goods, and services provided by or on behalf of the County.

WHEREAS the County provides information, goods, and services that are necessary and desirable in all or parts of the County;

AND WHEREAS this information, goods, and services may be provided upon the payment of a reasonable fee;

AND WHEREAS this Bylaw shall be known as the “Master Rates Bylaw”;

NOW THEREFORE pursuant to the provisions of the Municipal Government Act being Chapter M-26 of the Revised Statutes of Alberta, 2000, and amendments thereto, the Council of Cypress County in the Province of Alberta, duly assembled, hereby ENACTS AS FOLLOWS:

1. That administrative, assessment, development, planning, public works, utilities, recreation, agriculture, fire and other municipal services and fees be established as described in Schedule “A” attached.
2. That Bylaw 2021/16 is hereby repealed.
3. This Bylaw shall take effect upon passage thereof.

Read a first time this 18th day of January, 2022.

Read a second time this 15th day of February, 2022.

Read a third time and finally passed this 15th day of February, 2022.
